Subject: FY2014 Capital Budget - \$21 Million One-Time Capital Funding

The Alaska Department of Education & Early Development (DEED) is pleased to announce the Alaska Legislature's FY2014 Capital Budget one-time appropriation of \$21 million to be distributed as capital grants to school districts according to the adjusted average daily membership (AADM) for student safety and security enhancement, and for school districts with an average daily membership of 4,500 or less, for student safety and security enhancement and for fixed costs and energy relief.

The grant is capped at \$21 million and will be distributed based on the FY2014 AADM. DEED will distribute the funding in FY2014 in a manner similar to other prior year one-time funding. Please see the attached spreadsheet for the projected grant allocations for each school district. Districts should use GASB policy to record and account for the funds at the district level.

Please note that the FY2014 Capital Budget, Senate Bill 18, has been transmitted to the Governor and is subject to the Governor's approval.

Furthermore, DEED would like to thank the many Superintendents and other Administrators, who participated in DEED's February/March 2013 Statewide School Safety Survey, for their assistance in compiling an inventory of Alaska school safety needs. The information gleaned from this survey has been invaluable, and has been utilized to determine which school safety resources might be most helpful to bring to your attention. Attached, for your review, is the complete survey summary.

As part of DEED's ongoing commitment to ensure Alaska students' safety, we are considering a follow-up survey in November 2013 to continue to promote safe and supportive schools.

February/March 2013 School Safety Superintendent Survey Synopsis


Question 1

Can you please characterize your district's current level of school safety as it relates to **controlled school access?** (This question is seeking to clarify if schools have an established single point of entry for students and others to funnel through with all other doors locked and secure so guests can be monitored and assessed for safety. It also seeks to understand if this single point of entry is adequately monitored and if a system for approving and tracking guests is in place.)

District Response Rate: 83% (45 of 54 districts represented)

Statewide Average Response: 2.4 (falls into the inadequate range)

- Automated door locks/buzz-in system/swipe-card system (15 districts noted this)
- Structural challenges/design issues of schools limiting visibility and ability to monitor students and visitors entering the building (11 districts noted this)
- Additional staffing needed to monitor main school entrances (4 districts noted this)




Can you please characterize your district's current level of school safety as it relates to **hardware**? (security cameras, good locks on classroom doors, PA systems, handheld radios, etc.)

District Response Rate: 83% (45 of 54 districts represented)

Statewide Average Response: 2.2 (falls into the inadequate range)

- Need security cameras/video monitoring system (23 districts or 50% of reporting districts)
- Need upgrade of classroom door locks (11 districts)
- Need handheld radios (8 districts)
- Need public announcement/intercom system (6 districts)
- Need windows replaced/window treatments to limit visibility into school (4 districts)




Can you please characterize district staffs' current level of **training on crisis response preparedness?** (This question covers topics like annual crisis response training, updated crisis response plans at every school, and conducting regular emergency evacuation and lock down drills.)

District Response Rate: 85% (46 of 54 districts represented)

Statewide Average Response: 3.3 (falls into the adequate range)

- Need training by external experts on Crisis Response
- Need more school/district level practice on emergency preparedness and Crisis Response




Can you please characterize your district's current level of **training on**programs/practices/policies that promote positive school climate, and training for staff on
identifying students with mental health issues that may constitute a danger to self or others?

District Response Rate: 85% (46 of 54 districts represented)

Statewide Average Response: 3.2 (falls into the adequate range)

- Need counselors/more counseling services (5 districts)
- Need training on bullying prevention (2 districts)
- Need training on identifying students/others who pose danger to self or others (2 districts)



Is there **anything else related to school safety**/emergency preparedness not captured above you would like me to know?

District Response Rate: 83% (45 of 54 districts represented)

Statewide Average Response: N/A (this question did not use the 1-5 scale)

- Need more village police officers (4 districts)
- Need more school resource officers (4 districts)
- Need more state level support--safety resources and personnel (4 districts)
- Need more school safety conferences (3)
- Need training for school personnel to carry firearms (3)
- Need more capacity to evacuate students in time of emergency (2)
